Come join us to sell or promote your business, products, or organization.

- Vendor Fee for For-Profit Groups is **\$150** for the weekend. (\$25 discount for payment by March 1st, 2023)
- Vendor Fee for Non-Profit Groups is **\$100**
- Spaces are outdoors and on grass, approximately 12x12 feet. Larger sizes available upon request and for an additional fee. **NOTE:** If a tent is used, any tent over 120 sq feet has a fee and is required to be inspected by the local fire department. Consult the Community Event Handbook below with questions or contact the City of Akron, Community Event office at 330-375-2835
- REVIEW the City of Akron, Community Event Handbook. It is your responsibility to ensure you meet ALL requirements to operate in the city. <http://www.akronohio.gov/cms/communityevents/index.html>
- Electricity is **NOT** available in the vendor area, quiet generators (that do not disturb other vendors or customers) are acceptable (Please indicate if you are bringing your own generator). Spaces are preassigned, so please advise of any special requests.
- Weather permitting, set-up may begin as early as Friday, Aug 18th at 3pm but no later than 6:30 p.m. A volunteer will be in the vendor area if you need assistance.
- Vendors must arrive and set up by 9:30am on Saturday and Sunday. All vehicles will be out of the show area when the gate opens to the public. There will be a 15-minute warning. Any vehicles left in the area will get two additional warnings before it is towed at the owner's expense.
- **NO LOUDSPEAKERS OR BALLOONS WILL BE PERMITTED**
- You may not sell food, beverages, or anything illegal, under local, state, or federal law. Please do not bring or consume alcoholic beverages before, during or after on the airport property.
- **Vendors are required to promote attendance at the Festival on Vendor's website and/or social media platforms** and shall specifically tag or otherwise highlight and reference the “Props and Pistons Festival” and freely share its posts and updates.
- Vendor shall be required to present a Certificate of Insurance, 60 days prior to the Festival, with limits of coverage naming the “Props and Pistons Festival” as an additional insured. Failure to provide any document by any deadline will result in the loss of the Vendor fee and/or the denial of space and participation in the Festival upon the sole discretion of PAPF.

- NO REFUNDS. Once you have paid there will be no refunds of any sort.
